

## Terms and Conditions: PAGEIIT (Pty) Ltd

Account holders must comply with our up to date Terms & Condition, Policy Privacy and other site policy applicable to the Pageiit (Pty)Ltd. Account holders must acknowledges that failure to comply with the terms & conditions and private policy may result to a member being ban for using our services.

1. In line with and subject to the terms and conditions, Account holders have the power to choose how they want to communicate with clients. Moreover the Account holders in their profile may choose from emails, contact number or social media platform to communicate with their clients. Pageiit does not encourage personal information to be displayed on a profile. Remains the Member's responsibility on displaying information on their profile.
2. Account holder understands that (i) any user personal information made available by Company to display is solely to enable clients to contact such user for the purpose of replying and establish communication; (ii) Account holders is responsible for complying with all laws associate with the processing of personal information, including user information made available by Company in their profile. Any agreement between the client and the account holder remains the responsibilities of both parties. Pageiit (Pty) Ltd does not participate or negotiation between the two parties we can only get involve if there's an illegal activist or fraud of some sort.
9. Personal information is only required to recreate an account and secure it. Pageiit (Pty) Ltd is prohibited to share your personal information with other Account holders or clients. The account own remain his/her decision on the information they want to share and how he/her want to communicate with clients.
